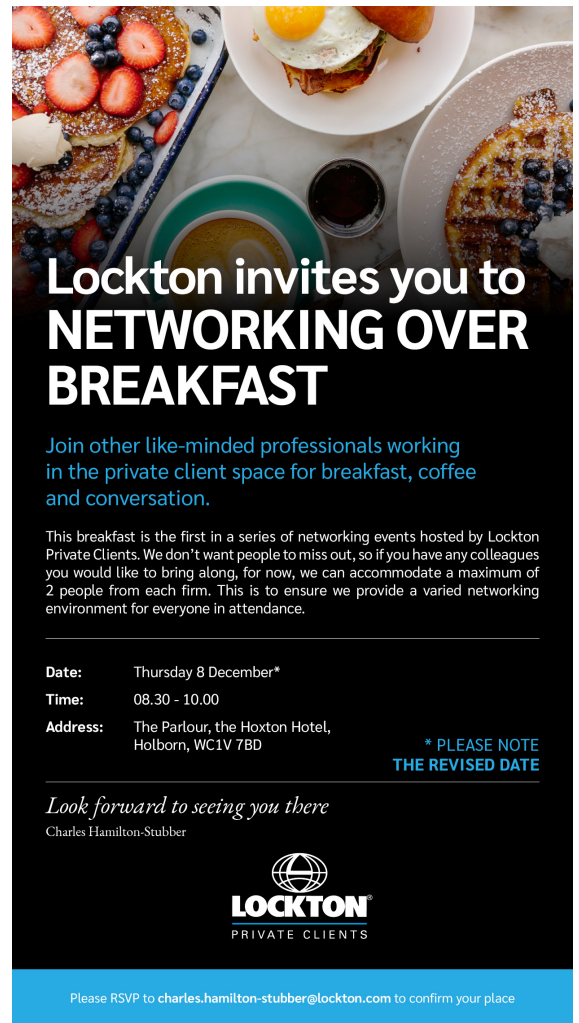

Confidentiality

Lockton will maintain confidentiality; but if we decide that it is appropriate to conduct an investigation, this will normally require limited disclosure on a "need to know" basis. For example, the person you are raising issues about will have to be given sufficient information to allow them to respond to the allegations, and this will mean revealing the nature of the allegation and will almost certainly mean revealing your identity. Some details may also have to be given to potential witnesses, but the importance of confidentiality will be emphasised to them.

If the allegation is upheld, and if Lockton continue to employ the person who has found to harass/inappropriate behaviour against you, then we may need to give that manager/HR Business Partner some information about the complaint so that they can manage future working relationships.

If the matter you raise has implications for the safety and wellbeing of your colleagues or leads to legal action, we may be required to disclose matters we would otherwise keep confidential, but we will always keep you informed if that situation arises.

I am a witness - What to do

There may be occasions where you may witness inappropriate behaviour towards one of your colleagues or another third party - whether in a Lockton office, at client site, at work event or even a social setting where colleagues, clients and/or third parties who are connected to Lockton are present. Early intervention is key and it goes to the heart of Lockton's culture to support our colleagues/clients and to be an ally in such circumstances is important to maintaining relationships, which is critical to the success of our business.

Please follow 'the 4 S's' below:

- Speak out:** At the time - be brave and don't be afraid to call out behaviour in real time (whether you are offered directly impacted personally or not), and advise the person that you do not feel that their behaviour is appropriate, and it may be appropriate to take steps to send them home safely in a taxi etc. In addition, if possible checking with the individual before, raise it with the most senior Lockton person present who may be able to support you and the individual who has been subject to the behaviour.
- Safe space:** At the time - as soon as possible to send remove yourself and your colleague who has been subjected to the behaviour to a safe space, away from the person who has been behaving inappropriately.
- Speak up:** After the incident - even if you have spoken out at the time - as the earliest opportunity - it is important you raise the matter with HR and line manager (if not the subject of the allegation) who can provide further advice and support. Alternatively, you may want to call SafeCall, Lockton's independent whistleblowing helpline, on 0870 2419762. The service is available 24 hours a day.
- Seek and signpost support:** See above for the ideas of where to signpost the impacted person to support you.

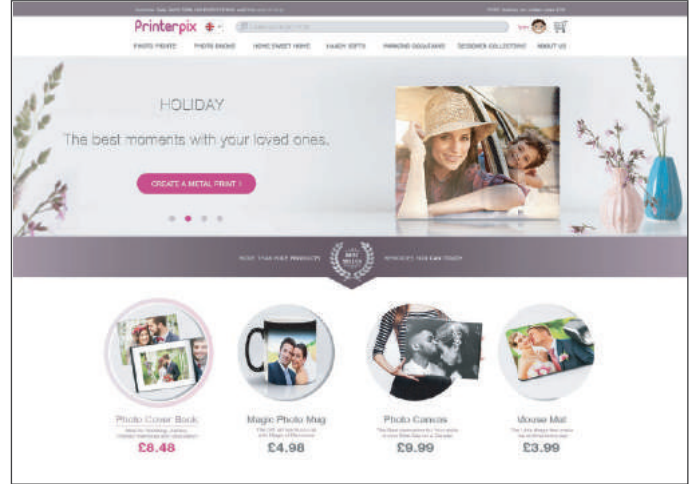
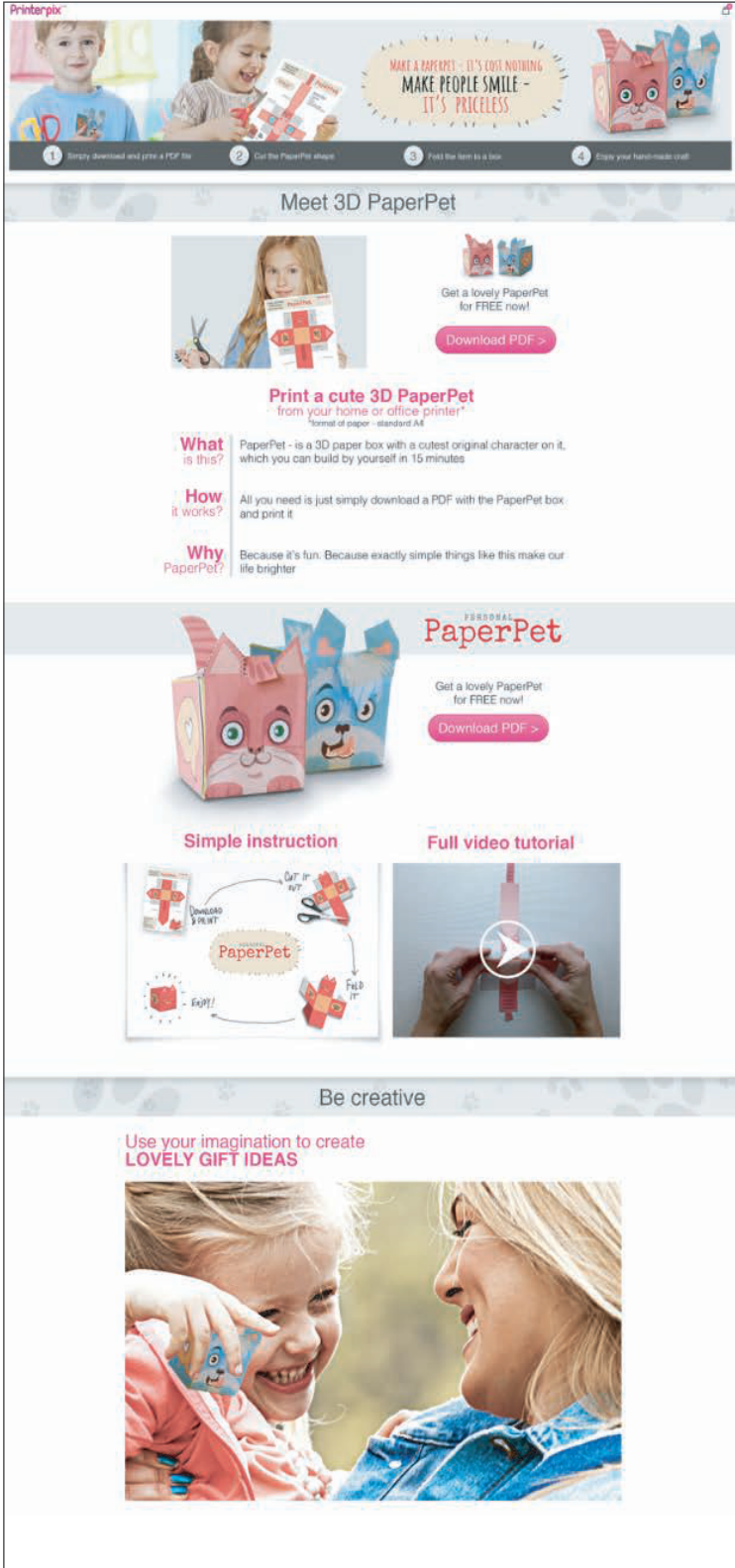

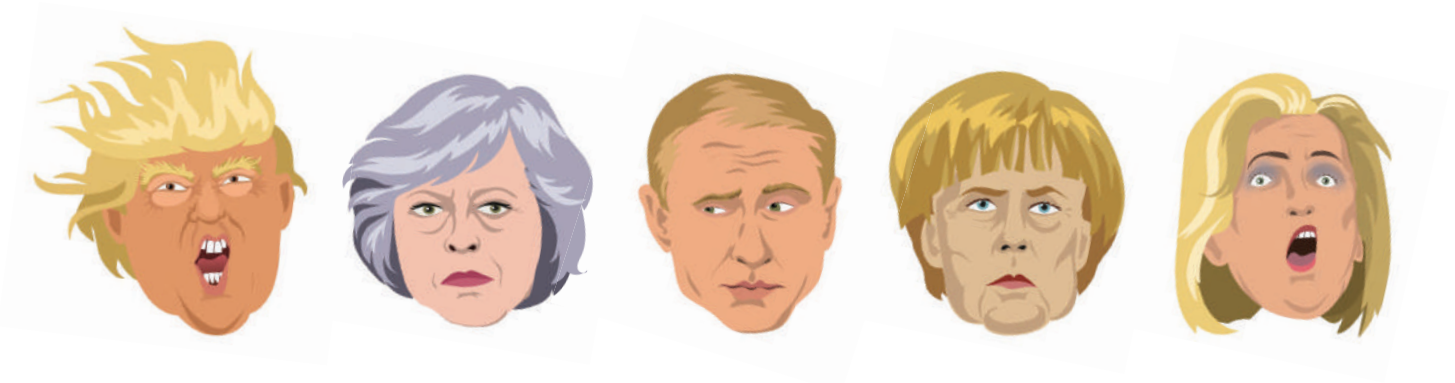
